I refer to your application made under the *Freedom of Information Act 1991* (the FOI Act) on 17 May 2023 for access to:

"Police Minister's office documents, specifically ministerial briefings and attachments, reports, audits and correspondence including emails, relating to police recruitment, from 1 January 2023 to 11 May 2023".

A search of this agency's records has identified twelve (12) documents within the scope of your application. The documents are identified in the attached schedule.

In accordance with section 20(4) of the FOI Act, I have determined to grant you partial access to documents 7-12.

Information concerning the personal affairs of a person have been redacted in accordance with clause 6(1) of the FOI Act.

Section 20(1)(a) of the FOI Act provides that an agency may refuse access to a document if the document is exempt. I have determined to refuse access to documents 1-6. These documents contain matters the disclosure of which would disclosure information concerning any deliberation or decision of Cabinet.

If you are unhappy with this determination you are entitled to apply for an internal review in accordance with section 29 of the FOI Act. To make an internal review application, please either write a letter or send the attached form entitled *Application for Review of Determination* to the Principal Officer of this agency, the Hon Joe Szakacs MP, within 30 (calendar) days after you receive this letter.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, will be published in the agency's disclosure log.
